Honorable Speaker Nancy Pelosi, CA Public Health Officers and Broadband Coalition Among Awardees

(Sacramento, CA) – During the 127th Annual Meeting, the California State Association of Counties (CSAC), the voice of California's 58 Counties at the state and federal levels, recognized a host of individuals and organizations for their service to local communities and the public at large.

These awards and recognitions honor those who have gone above and beyond and represent the best on County and Public Service," said CSAC Executive Director Graham Knaus. Retired San Diego County Supervisor Greg Cox was honored with the Lifetime Achievement Award. Former Supervisor Cox is the only person to have served as past president of the League of California Cities, CSAC, and the National Association of Counties.

Jenny Chamberlain, Chief of Staff in Sonoma County, was bestowed the CSAC President's Award by outgoing CSAC President and Sonoma County Supervisor James Gore.

Five Distinguished Service awards were presented to individuals who made the greatest contributions to the improvement of government in California, particularly as it relates to County government. Recipients for 2021 include:

- Madame Speaker Nancy Pelosi, with the United States House of Representatives for her unwavering leadership and commitment to Counties in negotiations for the Coronavirus Local Fiscal Recovery Fund in the American Rescue Plan Act;
- Assemblymember Cecilia Aguiar-Curry and Senator Lena Gonzalez for their leadership in broadband advocacy;
- Ana Matosantos, Cabinet Secretary for Governor Gavin Newsom, for her leadership and partnership throughout the COVID-19 pandemic; and
- Jason Elliot, Senior Counselor to Governor Gavin Newsom, for his role in advising on housing and homelessness initiatives.
