The California Governor's Office of Emergency Services (Cal OES), Grants Management is soliciting proposals for the following FY 2024 SLCGP Competitive Funding Opportunities:

SLCGP for Local and Tribal Governments (SL) Program

For FY 2024, \$19,085,028 in SLCGP funds is available for the SL Program CFO. The purpose of this competitive grant opportunity is to assist local governments, including school districts and special districts, and federally recognized tribes address cybersecurity risks and threats to information systems, and improve security of critical infrastructure and resilience of the services these entities provide to their communities.

SLCGP for State Agencies (SG) Program

For FY 2024, \$3,578,443 in SLCGP funds is available for the SG Program CFO. The purpose of this competitive grant opportunity is to assist agencies of the State of California address cybersecurity risks and threats to information systems, and improve security of critical infrastructure and resilience of the services these entities provide to communities throughout the state.
